## **SECTION I: GENERAL TERMS & CONDITIONS**

- 1. Centre for Development of Advanced Computing (CDAC) is a Scientific Society of Department of Electronics & Information Technology (DeitY) invites sealed bids from eligible bidders for Comprehansive Maintenance Contract of Desktops/laptops/Server/Printers etc.
- **2.** Period of AMCOne year, which can be further extended.
- **3.** Vendors should be registered with appropriate authority.
- **4.** Company/firm should have experience of atleast five years.
- **5.** The company should have well established workshop with sufficient & experienced engineers.
- **6.** The response time of the complain shall be one day except Saturday/Sunday/Holidays.
- 7. The firm should have sufficient stocks of the spares for replacement.
- **8.** Payment will be made quarterly after verification of service by the System Administrator of C-DAC.
- **9.** Penalty will be imposed @ 1% with a maximum5% per week if the down time is not maintained as mentioned at V above.
- 10. The Vendor should have ISO Certification (preferably) for service & maintenance.
- **11.** The price quoted shall be considered firm and no price escalation will be permitted.
- **12.** <u>Taxes and Duties:</u> The basic prices and applicable taxes should be mentioned separately. The exact amount/ rate of taxes applicable, as on the date of quoting must be mentioned. No concessional tax form (C/D) will be given by CDAC
- **13.** <u>Jurisdiction:</u> The disputes, legal matters, court matters, if any shall be subject to Delhi jurisdiction only.
- 14. <u>Force Majeure:</u> CDAC may consider relaxing the penalty and delivery requirements, as specified in this document, if and to the extent that, the delay in performance or other failure to perform its obligations under the contract is the result of an Force Majeure. Force Majeure is defined as an event of effect that cannot reasonably be anticipated such as acts of God (like earthquakes, floods, storms etc.), acts of states / state agencies, the direct and indirect consequences of wars (declared or undeclared), hostilities, national emergencies, civil commotion and strikes at successful Bidder's premises or any other act beyond control of the bidder.
- **15.** <u>Arbitration:</u> All disputes/clams of any kind arising out of supply, commissioning, acceptance, warranty maintenance etc under this Contract, shall be referred by either party (CDAC or the bidder) after issuance of 30 days notice in writing to the other party clearly mentioning the nature of dispute to the Sole Arbitrator appointed by CDAC. The venue for arbitration shall be specified in the Work Order/agreement. The arbitration proceedings shall be conducting in English and as per the provisions of Indian Arbitration and Conciliation Act, 1996. The decision of the Arbitrator shall be final and binding on both the parties.
- **16.** Indemnity:\_Selected bidder shall save and indemnify and hold harmless CDAC from any third party Government claims, losses, and penalties, if any, arising in connection with this contract.
