7. Proposal Submission

- i. The prospective agencies should take into account any corrigendum published regarding this EoI document before submitting their proposals.
- ii. The documents should be scanned in 100 dpi with black and white option.
- iii. The prospective agency may submit the proposal for selection to collaborate in one or multiple of the following areas Quantum Computing, Post Quantum Cryptography, Sustainability and Green technologies, AI/ML, Smart Card Technologies, VLSI and Reconfigurable Hardware Systems, Crypto devices, AFC System, Embedded Systems & IoT and Blockchain Technology. Similarly the prospective agency may submit the proposal for selection in one or multiple of the following engagement modes Collaborative Development Partner (CDP), Deployment Partner (DP) and Training Partner (TP).

10. Validity

The proposal submitted shall remain valid for a period of at least 120 days from the date of submission.

11. Last Date of Submission of Proposals

Last date for uploading/sending the e-proposals is as per details given in Activity Schedule. The payment towards document processing fees must be done through online transfer (C-DAC Noida shall not be responsible for any delays or any other reason for not submitting the fees in the specified time and resulting in disqualification/rejection of any proposal) so as to reach on or before the due date and time. Bank details as mentioned in the activity schedule.

SECTION II: INSTRUCTIONS TO PROSPECTIVE AGENCY

1.Period of Engagement

The initial period of engagement with the shortlisted agencies shall be two (02) years. C-DAC, Noida reserves the right to extend this period by another one/two years on same terms and conditions. More agencies can be added in the empanelled list, provided they meet the terms and conditions set out under this EoI.

2. Eligibility Criteria

All the prospective agencies must meet the minimum eligibility criteria given below.

a) General Eligibility Criteria

- a. The bidder should be an Indian entity registered under Companies Act 2013 or under section 59 of Partnership Act 1932 or under the Limited Liability Partnership Act 2008, in India.
 - Copy of Certificate of Incorporation/ Registration/ Partnership Deed or any other relevant document, as applicable, should be submitted along with a copy of address proof.
- b. The bidder shall be in operations in India for a period of at least five (5) years as on published date of EoI. Required 5 years Audited Balance sheet with P&L Account to know the operations business in India for the last 5 years i.e. 2018-19, 2019-20, 2020-21, 2021-22 and 2022-23.
- c. The minimum average annual turnover of the bidder in last 3 financial years shall be INR 50 L. Required Audited Balance sheet alongwith P & L Account 2020-21, 2021-22 and 2022-23 alongwith CA Turnover Certificate.
- d. The bidder shall have positive net-worth in the last 03 Financial Years. Required CA Certificate for Net worth.
- e. ITRs copy may also be asked from the Bidder for the last 3 years.
- f. The bidder should have a valid PAN and GST Registration (copy of PAN card and GST Registration Certificate should be submitted in the bid). In case GST Registration is not available, the bidder shall give undertaking that it will get registered before start of work, if work is awarded to them.
- g. The bidder shall submit an undertaking on their letter-head stating that:
 - "In reference to the Government of India, Ministry of Finance, Department of Expenditure, Office Memorandum No. F.No. 6/18/2019-PPD, Dated 23-07-2020. I hereby submit that, we have read the Clause regarding restrictions on procurement from a bidder of a country which shares a land border with India;
 - We are from such a country and have been registered with the competent authority. The copy of valid registration certificate is enclosed. OR
 - We certify that we are not from such a country or the beneficial owner is not from such a country or we will not sub-contract any work to a contractor from such countries.
- h. Proof of PF registration to be submitted by the bidder, if the bidder comes under PF.
- i. Bid by Consortium is not allowed.
- j. The bidder should not be insolvent, in receivership, bankrupt or being wound up, not have had their business activities suspended and not be the subject of legal proceedings for any of the foregoing. An undertaking by the bidder should be submitted.
- k. The bidder should not be blacklisted/debarred/banned/restricted by any Union Govt./State Govt. /PSU as on date of submission of the Bid.

b) Specific Eligibility Criteria

For Domain Verticals please refer to Section III para 2.

i) Eligibility criteria for Collaborative Development Partner (CDP):

The bidder must have

- At least three ongoing projects of value Rs 1 Crore and above *OR* one completed project with value Rs 50.00 Lakhs and above that involve design and development of products/solutions in one or more of the mentioned technologies and associated areas (OR) At least three Patents/Copyrights filed OR one Patent/Copyright awarded in the mentioned technologies and associated areas.
 - **(OR)** Developed atleast two products/solutions in the mentioned technologies and associated areas, out of which, a minimum of one is deployed at least as PoC.
- At least 5 well qualified personnel (Masters in Science / Bachelor in Engineering) on roll, out of which atleast 2 should possess a minimum of Bachelor's degree in Engineering and possess work experience (end to end) in the mentioned technology verticals and associated areas as on date of submission of proposal.

ii) Eligibility criteria for Deployment Partner (DP)

The bidder must have

- At least three projects executed with value Rs. 2 Crores and above *OR* one on-going project with value Rs 1 Crore and above that involve deployment of products/solutions in one or more of the mentioned verticals and related areas.
 - **(OR)** Must have deployed at least one product/solution with more than one lakh users in the mentioned vertical and related areas.
- At least 5 well qualified personnel (Masters in Science / Bachelor in Engineering) on roll, out of which atleast 2 should possess a minimum of Bachelor's degree in Engineering and possess work experience in the mentioned technology verticals and associated areas as on date of submission of proposal.
- Sales and support mechanisms at least in three locations in the country.

iii) Eligibility criteria for training partner (TP):

The bidder must have

- Delivered at least two online training courses *OR* one offline course in the mentioned technologies and associated areas.
- At least 5 well qualified personnel (Masters in Science / Bachelor in Engineering) on roll, out of which atleast 2 should possess a minimum of Bachelor's degree in Engineering offering the training and has domain knowledge in the mentioned technologies and associated areas.
- Trained at least 2000 persons through online *OR* 200 persons in the offline mode during the last one year in the mentioned technologies and associated areas.

Note: The prospective agencies (Bidder) should provide sufficient documentary evidence to support the eligibility criteria. C-DAC Noida reserves the right to reject any proposal not fulfilling the eligibility criteria.

3. Earnest Money Deposit (EMD)

The bidders shall sign a Bid Security Declaration (as per format given in EoI - Annexure E) accepting that if they withdraw or modify their bids during the period of validity etc., they will be suspended for the time specified in the EoI document.

Note:- Bids received without Bid Security Declaration form shall be summarily rejected.

4.Exemptions

If in the view of the agencies, any exemption/relaxation is applicable to them from any of the eligibility requirements, under any Rules/Guidelines/Directives of Government of India, agencies may submit their claim for the applicable exemption/relaxation, quoting the valid Rule/Process/Guidelines/Directives. In this case the agencies must submit necessary and sufficient documents along with their proposal, in support of this claim. The decision about granting the exemption/relaxation will be taken by the evaluation committee which is empowered to grant exemption/relaxation.

5.Desired Credentials

Over and above the eligibility criteria stipulated above, the additional credentials are desirable and will be given added weightage, as detailed in **Section – II**, "Evaluation of Proposals".

6.Amendments to EoI Document

- a) At any time prior to the deadline for submission of proposals, C-DAC Noida may, for any reason, whether on its own initiative or in response to the clarification request by a prospective agency, modify the EoI document.
- b) The amendments to the EoI documents, if any, will be notified by release of corrigendum notice on https://eprocure.gov.in website. The amendments/ modifications will be binding on the prospective agencies.
- c) C-DAC Noida at its discretion may extend the deadline for the submission of proposals if it thinks necessary to do so or if the proposal document undergoes changes during the submission period, in order to give prospective agencies time to take into consideration the amendments while preparing their proposals.

7. Preparation of Proposals

- a) Prospective agency should avoid, as far as possible, corrections, overwriting, erasures or postscripts in the proposal documents. In case however, any corrections, overwriting, erasures or postscripts have to be made in the proposals, they should be supported by present date signatures of the same authorized person signing the proposal documents.
- b) Prospective agency shall not be entitled to amend add/delete/correct the clauses mentioned in the entire tender document.

8. Technical Presentation

Subsequent to submission of proposals, the Evaluation Committee of C-DAC Noida may ask the eligible prospective agencies to give a detailed technical presentation, covering following points:

- a) Company Profile and nature of their activities.
- b) Knowledge, skills, expertise pertaining to the areas for which proposal is submitted (primary focus).
- c) Achievements, awards won, etc.
- d) Potential and priority areas for collaboration/indicative roles & responsibilities/Plan/methodology for rendering the services for which the proposal is submitted.
- e)Capability and willingness.
- f) Any other differentiators.

9. Evaluation of Proposals

- a) The proposals will be evaluated in two steps. The proposals will be examined based on eligibility criteria stipulated at Section II to identify the eligible agencies.
- b) The eligible agencies will be invited for the technical presentation. The shortlisting of the agencies will be finalized after technical presentation and evaluation.

10. C-DAC's Right to Amend/Cancel

- a) C-DAC Noida reserves the right to amend the eligibility criteria, scope of supply, technical specifications etc.
- b) C-DAC Noida reserves the right to cancel the entire EoI without assigning any reasons thereof.

11. Corrupt or Fraudulent Practices

- a) It is expected that the prospective agency who wish to enrol as agency should have highest standards of ethics.
- b) C-DAC Noida will reject proposal if it encounters that the prospective agency recommended for award of contract has engaged in corrupt or fraudulent practices while competing for this contract.
- c) C-DAC Noida may declare a prospective agency ineligible, either indefinitely or for a stated duration, to be awarded a contract if it at any time encounters that the prospective agency has engaged in corrupt and fraudulent practices during the award/execution of contract.

12. Penalty for Use of Undue Influence

The prospective agency undertakes that he has not given, offered or promised to give, directly or indirectly, any gift, consideration, reward, commission, fees, brokerage or inducement to any person employed in C-DAC Noida or otherwise in procuring the contract/agreement or forbearing to do or for having done or forborne to do any act in relation to the obtaining or execution of the contract/agreement or any other contract/agreement with the Government of India for showing or forbearing to show favour or disfavour to any person in relation to the contract/agreement or any other contract/agreement with the Government of India. Any breach

of the aforesaid undertaking by the prospective agency or anyone employed by him or acting on his behalf (whether with or without the Knowledge of the prospective agency) or the commission of any offence by the prospective agency Partner or anyone employed by him or acting on his behalf, as defined in Chapter 9 of the Indian Penal Code, 1860 or the Prevention of Corruption Act 1986 or any other Act enacted for the prevention of corruption shall entitle C-DAC Noida to cancel the contract/agreement and all or other contract/agreements with the prospective agency and recover from the prospective agency the amount of any loss arising from such cancellation. The decision of C-DAC Noida to the effect that a breach of the undertaking had been committed shall be final and binding on the prospective agency, giving or offering of any gift, bribe or inducement or any attempt at any such act behalf of the prospective agency toward any officer/employee of C-DAC Noida or to any other person in a position to influence any officer/employee of C-DAC Noida for showing any favour in relation to this or any other contract/agreement, shall render the prospective agency to such liability/penalty as C-DAC Noida may deem proper, including but not limited to, termination of the contract/agreement, imposition of penal damages, and refund of the amount paid by C-DAC Noida.

13. Confidentiality

The agency and/or their personnel shall not, either during the term or after expiration of engagement period disclose any proprietary or confidential information relating to the services, contract or C-DAC's business or operations without the prior written consent of C-DAC Noida. The agency and/or their personnel shall not, either during the term or after expiration of this contract, undertake any public communication, press/media releases relating to the services, contract, or C-DAC's business or operations without the written consent of C-DAC Noida. Information available on public domain is excluded from confidentiality clause.

14. Force Majeure

C-DAC Noida may consider relaxing the penalty and delivery requirements, as specified in this document, if and to the extent that, the delay in performance or other failure to perform its obligations under the contract is the result of an Force Majeure. Force Majeure is defined as an event of effect that cannot reasonably be anticipated such as acts of God (like earthquakes, floods, storms etc.), acts of states/state agencies, the direct and indirect consequences of wars (declared or undeclared), hostilities, national emergencies, civil commotion and strikes at agency's premises or any other act beyond control of the agency.

15. Arbitration

In case any dispute arises between the C-DAC Noida and successful agencies with respect to this EoI, including its interpretation, implementation or alleged material breach of any of its provisions both the Parties hereto shall endeavour to settle such dispute amicably. If the Parties fail to bring about an amicable settlement within a period of 30 (thirty) days, dispute shall be referred to the sole arbitrator mutually appointed by both parties. If the sole arbitrator is not appointed mutually by both the parties then the District Court Noida shall have exclusive jurisdiction for appointment of sole arbitrator through court. Arbitration proceedings shall be conducted in accordance with the provisions of the Arbitration and Conciliation Act, 1996 and Rules made there under, or any legislative amendment or modification made thereto. The venue

of the arbitration shall be Noida. The award given by the arbitrator shall be final and binding on the Parties. The language of arbitration shall be English. The common cost of the arbitration proceedings shall initially be borne equally by the Parties and finally by the Party against whom the award is passed. Any other costs or expenses incurred by a Party in relation to the arbitration proceedings shall ultimately be borne by the Party as the arbitrator may decide. Courts in Noida only shall have the exclusive jurisdiction to try, entertain and decide the matters which are not covered under the Arbitration and conciliation Act.

16. Indemnity

Selected agencies may please note that, C-DAC Noida shall neither be the Employer of nor shall it be deemed to be the principal employer of any persons to be deployed by the agencies towards the service rendered and shall not in any manner be responsible for any act, omission or commissions by the agencies, the manpower deployed for this project or by his employees, in respect of any non-compliance of all or any labour and other laws statutory notifications, relevant rules and regulations applicable to the provision of Provident Fund and ESIC of the persons engaged by the supplier and no claim in the respect shall lie against C-DAC Noida. The agencies shall keep indemnified C-DAC Noida for any such claim raised by employees of the agencies.

It may be expressly understood that the relationship between the parties hereto is as Principal – to – Principal and the agencies shall not be an agent of C-DAC Noida for any purpose whatsoever, and shall not represent or hold himself out as such to any person/s.

17. Limitation of Liability

- 1. The maximum aggregate liability of selected agencies in respect of following cases shall not exceed the total amount of the Contract/ Works Order:
 - i. Any claims, losses, costs or damages arising out of or in connection with the Contract/ Works Order or SoW.
 - ii. Damage(s) occasioned by agencies for breach of Confidentiality Obligations.
 - iii. Regulatory or statutory fines imposed by a Government or Regulatory agencies for non-compliance of statutory or regulatory guidelines, Rules, Regulations etc., were brought to the notice of agencies.
- 2. The liabilities- if any with respect to the following shall be at actuals:
 - i. Claims that are the subject of indemnification pursuant to infringement by the agencies of third party Intellectual Property Right.
 - ii. Damage(s) occasioned by the Gross Negligence or Willful Misconduct of the agencies.
- 3.Under no circumstances shall either Party be liable for any indirect, consequential or incidental losses, damages or claims including loss of profit, loss of business or revenue.

18. Termination

Validity of order/contract will remain till fulfilment of all obligations pertaining to development and successful deployment of software including (but not limited to) the terms and conditions stipulated in the order, for the period stipulated in the Order. C-DAC Noida reserves the right to terminate the contract/cancel order with or without cause/reason by giving 60 days' notice to the selected agencies. The selected agencies may terminate the Service Agreement /Order by at least 30 days written notice, in the event of non-payment of undisputed invoices for 60 days from the due date. All amounts which are due and payable to

the Vendor shall be immediately be paid by C-DAC Noida in the event of termination of the agreement for any reason whatsoever.

19. Assignment

Selected agency shall not assign, delegate or otherwise deal with any of its rights or obligation under this contract without prior written permission of C-DAC Noida. The prime responsibility towards the successful execution of agreement/contract lies with prospective agency associating with C-DAC Noida. The selected agency shall not fully or partially sub-let to any other entity without prior approval and written consent of C-DAC Noida.

20. Severability

If any provision of this contract is determined to be invalid or unenforceable, it will be deemed to be modified to the minimum extent necessary to be valid and enforceable. If it cannot be so modified, it will be deleted and the deletion will not affect the validity or enforceability of any other provision.

21. Interpretation of the Clauses in the EoI Document

In case of any ambiguity/dispute in the interpretation of any of the clauses in the EoI document, the interpretation of the clauses by Director General, C-DAC shall be final and binding on all parties.

SECTION III: SCOPE OF SERVICES AND ROLES

1. Modes of Engagement

Selected agencies shall collaborate, develop, implement, test, maintain and support the solutions in the following Advanced and Emerging ICT&E Technologies - Quantum Computing , Post Quantum Cryptography, Sustainability and Green technologies , AI/ML, Smart Card Technologies, VLSI and Reconfigurable Hardware Systems, Crypto devices, AFC System, Embedded Systems & IoT and Blockchain Technology. The solution may also encompass software/hardware products in the identified ICT&E technologies and associated areas. It is envisaged to have end to end collaboration from development to release processes including deployment automation, scalable, seamless deployment and operations. The systems so developed should be effectively tested, modular and robust. As per project demands, such agencies should be ready to provision design, develop and deploy the hardware /software products, project management & planning. Selecting agencies shall collaborate in training and capacity building activities in the identified technologies and associated areas. The proposed modes of engagement, not limited to, are as follows.

A. Collaborative Development Partner (CDP)

In this mode, the selected agency should complete the development and/or implementation and/or maintenance of equipment/applications and/or modules as per the scope and milestones stated in Statement of Work. The selected agency will be responsible for the successful outcome as per the acceptance criteria and milestones defined in SoW. CAFC was Pilot tested in B.E.S.T., Mumbai at two depots-Wadala & Colaba with 9 banks NCMC cards.

CAFC offers complete e-ticketing solution comprising of – Depot Operations Management, Transaction management, Equipment management, Reconciliation, fund settlement and Strategic data analysis. CAFC Supports multiple payment modes: NCMC Card, QR Coded tickets and Cash. CAFC offers Near Real time review and status monitoring of entire value chain.

3)QR Ticketing System for Transit Operators:QR Ticketing offers facility of single or multiple journey QR coded tickets for an individual or group. - b)Limited enquiries will be sent to the shortlisted agencies for submitting the technocommercials proposals for the identified Projects. C-DAC reserves the right to invite the proposals from all the bidders who are shortlisted for respective verticals.
- c) The successful prospective agency will be required to submit the performance bank

- guarantee (3-10% of order value) for future project specific work orders through tender as applicable.
- d) The contract will be awarded to the eligible agency offering most competitive prices and meeting the technical criteria. C-DAC reserves the right to evaluate the offer and award the contract on the basis of Quality and Cost Based System (QCBS)/Least Cost Selection (LCS) as applicable.
- e) The value of individual order/contract may vary from project to project, depending upon the type of engagement as mentioned in "Objectives" section, nature and complexity of the project.
- f) The detailed scope of services, terms and conditions of work shall be stipulated in 'SoW' (Statement of Work) to be signed by both the parties before release of individual order.
- g) The contract may include terms related to penalty for delay in meeting the deadlines.
- h) The contract may include terms related to penalty for non/short performance.
- i) The contract may include terms related to Change order procedure for variation in scope of services or changes in requirements.
- i) The contract may include terms related to taxes and tax/duty exemptions.

5. Obligations of the Agencies

- a. **Standard of Performance:** The agencies shall perform the Services and carry out their obligations hereunder with all due diligence, efficiency, in accordance with generally accepted professional standards and practices, and shall observe sound management practices, and employ appropriate technology and safe and effective equipment, machinery, materials and methods. The agencies shall always act, in respect of any matter relating to this engagement or to the Services, as faithful advisers to C-DAC Noida, and shall at all times support and safeguard C-DACs legitimate interests in any dealings with third Parties.
- b. **Prohibition of Conflicting Activities:** The agencies shall not engage and not allow their personnel to engage, either directly or indirectly, in any business or professional activities which would conflict with the activities assigned to them under this contract.
 - i. The agencies shall keep safe, secure, confidential and protect from unauthorized access, loss or damage all demographic information, and all documents, data and information of any nature provided to the agencies for the discharge of services.
 - ii. The agencies shall not store, copy, publish, print, interfere, tamper with or manipulate the information/data received from C-DAC Noida, other than that required for discharge of services.
 - iii. The agencies shall not give access to the information or data collected and received from C-DAC Noida in the course of discharge of services, to any person who is not authorized to handle the information or data. Information should only be given to authorized personnel and only used in the manner prescribed by C-DAC Noida.
- c. **General Confidentiality:** Except with the prior written consent of C-DAC Noida, the agencies and the Personnel shall not at any time communicate to any person or entity any confidential information acquired, stored and received from C-DAC Noida in the course of the Services, nor shall the agencies and the Personnel make public the recommendations formulated in the course of, or as a result of, the Services.

d. Accounting, Inspection and Auditing

i. The agencies (i) shall keep accurate and systematic accounts and records in respect of the Services hereunder, in accordance with internationally accepted accounting

principles and in such form and detail as will clearly identify all relevant time changes and costs, and the bases thereof, and (ii) shall periodically permit C-DAC Noida or its designated representative and/or C-DAC, and upto five years from expiration or termination of this contract, to inspect the same and make copies thereof as well as to have them audited by auditors appointed by C-DAC Noida or C-DAC itself as the case may be.

- ii. C-DAC Noida shall have the right to carry out inspection checks, audits of the agency's premises and/ or locations, facilities, or point of delivery of services performed under this contract.
- iii. C-DAC Noida shall have the right to carry out scheduled/un-scheduled visits to any of the locations, premises & facilities and oversee the processes and operations of the agencies.
- e. **Sub- contracting:** The agencies shall not be permitted to sub-contract any part of its obligations, duties, or responsibilities under this contract without the prior written approval of C-DAC Noida.
- f. **Reporting Obligations:** As per terms and conditions mutually agreed at the time of award of work.
- g. **Rights of Use:** All rights of use of any process, product, service, or data developed, generated, or collected, received from C-DAC Noida or any other task performed by the agencies under the execution of projects awarded under this contract, would lie exclusively with C-DAC or its nominated agencies in perpetuity free from all liens, encumbrances, and other third party rights and the agencies shall, wherever required, take all steps that may be necessary to ensure the transfer of such rights in favour of C-DAC or its nominated agencies.

h. Safety & Security of Data, Premises, Location/site

- i. The Data, information, documents provided by C-DAC Noida to the agencies is the property of C-DAC Noida. The agencies shall display due diligence in the handling of the said data and be responsible for the Data, thus provided.
- ii. The agencies shall not use the information, the name or the logo of C-DAC and or Government of India without authorization of C-DAC Noida.
- iii. The agencies shall not use and/or transmit any information, data, layouts, designs, diagrams, storage media (hard disk/tapes) or any other goods/material in physical or electronic form, which are proprietary to or owned by C-DAC, without prior written permission from the C-DAC.
- iv. The agencies shall follow the Security Guidelines issued by C-DAC Noida.
- v. The agencies would be governed by the provisions of the Law of the Land, including but not limited to the IT Act and other relevant Acts.
- vi. C-DAC reserves the right to carry out third party Audits of the agencies to ensure compliance of stated and implicit requirements.
- vii. The rogue behavior of the employees of agencies shall fall under the 'Unlimited liability' to the agencies.
- i. Equipment & Materials Provided by the agencies: Equipment or materials brought by the agencies and the Personnel and used either for the Project or personal use shall remain the property of the agencies or the Personnel concerned, as applicable. However, Equipment or materials bought/provided by C-DAC Noida for the use of agencies shall remain the property of C-DAC Noida.

- j. **Intellectual Property Rights (IPR):** All prior information, design & data existing with either party before the start of the collaboration (free existing IP) shall be the sole property of that party. The Intellectual Property Rights (IPRs) pertaining to development of technologies/components/subsystems/modules/software, undertaken as part of the projects awarded, shall be governed by IPR policy of the grantor institutions that funded the project. IPR details would be provided as part of terms and conditions on a case to case basis.
- k. **Assignment:** The agencies shall not assign, in whole or in part, any of their obligations under this contract without prior approval of C-DAC Noida.
- 1. **Agencies Personnel:** The agencies shall employ and provide qualified and experienced personnel as are required to carry out the Services. Upon engagement, successful agencies will appoint a technically competent person (Project Manager/Relationship Manager) as single point of contact (SPOC) for interaction with C-DAC Noida.

m. Development Sites

- i. Development work can be carried out at C-DAC Noida, agencies premises or at C-DAC's client site.
- ii. Based on the mutually agreed terms for specific work orders, the service provider may have to undertake travel of key resources to the project site for a specific phase of project as per the requirement of the project.
- iii. In case the development work is required to be carried out at agencies premises the required infrastructure will be provided by agencies. C-DAC Noida personnel may be contacted over telephone, VC, messenger etc. During development phase, visits by C-DAC Noida and agencies's personnel to each other's premises may be arranged whenever required.

6. Roles and Responsibilities of Agencies

7. Role and Responsibilities of C-DAC Noida

- b. To discuss and set milestones for the project
- c. To set targets of the agencies based on the milestones set above.

- e. To review and issue acceptance of the task completion report submitted by the agency.

8. Allocation and Award of Work

a. Selection of agencies for a specific Work Order

The requirements will inter alia include scope of system/application to be developed by agencies and maintenance support required for the same for a predetermined time period on need basis.
- ii. Based on the requirements, bids will be invited from shortlisted agencies. The bids will detail the approach to be followed to meet the requirements. The bids will also include the number and qualifications of the resources that will be provided for this requirement. These bids will be evaluated on Quality and Cost Based System (QCBS)/ Least Cost Selection (LCS) as applicable.
- iii. Detailed evaluation criteria will be indicated in the bid and would vary from system/application to system/application to be developed by agencies.
- iv. The agencies will also submit the estimated effort and time required for completion of work. Adherence to Acceptance Criteria would form an important parameter for evaluation and details of same would be provided in bid document.

b. Performance Evaluation of the agencies

- i. C-DAC will periodically and at the end of every project evaluate the performance of the agencies.
- ii. Evaluation will be based on the following:
 - a. Quality of Estimation and Scope Management. Effort estimate of approved "Change Requests" shall be added to initial estimate to come up with revised estimate.
 - b. Adherence to development schedule.
 - c. Quality of people deployed on the project.
 - d. Degree of use of tools. It is desirable to maximize use of tools for higher productivity and homogeneity of quality of deliverables.
 - e. Number and type of defects identified during User Acceptance Testing and Go-live.
