Subject: Notification of Written Examination for the post of Project Engineer (Fresher) — reg.

1. With reference to the recruitment process initiated vide Advertisement No. C-DACK/COCP/2025/01 dated 12.12.2025 (“Advertisement”) for engagement to the post of **Project Engineer (Fresher)** at C-DAC, Kolkata, it is hereby notified that a **Written Examination** is proposed to be held for candidates who have been **provisionally shortlisted** for the said post.
2. The date/time/venue of the Written Examination is tentative and may be rescheduled/changed due to administrative exigencies, force majeure, or any other reasons as deemed fit by C-DAC. Any such change shall be notified to candidates through the registered email address (and/or other official channels as decided by C-DAC), and candidates shall be responsible for tracking such updates. C-DAC shall not be liable for any costs or inconvenience incurred by candidates on account of such rescheduling/change.
3. Email communication has been issued to all concerned provisionally shortlisted candidates at their registered email addresses. Candidates are advised to check their inbox, spam folder, and junk folder regularly.

 - a. Provisional shortlisting for the Written Examination is **not** an assurance of selection/appointment, and is subject to verification of eligibility conditions, educational qualifications, age, experience (if applicable), reservation/relaxation claims, and any other requirements as per the Advertisement and applicable rules.
 - b. Any discrepancy, suppression of material information, or submission of false/forged documents/information at any stage shall render the candidature liable to **cancellation**, besides such further action as may be permissible under law.
5. **General Instructions (non-exhaustive).**
 - a. Candidates shall carry a **valid photo identity proof** (original) and a copy/print/digital version of the Admit Card, as required.
 - b. Candidates should plan to report sufficiently in advance; late entry, if restricted by examination instructions, shall be governed by the Admit Card terms.
 - c. Items such as mobile phones, smart devices, written material, or any prohibited articles shall be regulated strictly as per the Admit Card instructions; C-DAC may refuse entry or take action in case of violation.
 - d. No TA/DA shall be admissible for appearing in the Written Examination unless specifically stated otherwise.

C-DAC reserves the right, at its sole discretion and without assigning reasons, to cancel, postpone, modify, restrict, curtail, or extend the recruitment process and/or the Written Examination (including date/venue/instructions) at any stage. Any updates which are issued shall be communicated through the registered email and/or official notification channels as decided by C-DAC.
7. The decision of the Competent Authority, C-DAC, shall be final and binding on all matters relating to this recruitment, including (without limitation) eligibility, conduct of examination, evaluation, shortlisting, and further stages of selection.
8. Any dispute arising out of or relating to this recruitment process shall be subject to the jurisdiction of the competent courts/tribunals at Kolkata, unless otherwise mandated by applicable law.
