***Invitation for Expression of Interest***

Expressions of Interest (Eol) are invited from reputed firms/companies, incorporated in India, with relevant experience/insights in the field of professional electronics for participation in Phase-2 of **Transfer of Technology (ToT) and Licensing of TETRA based products/technologies** developed by C-DAC, covering all products available in C-DAC TETRA portfolio as on date, including those listed for ToT/Licensing in Phase-1 of this process.

1. Those firms who are already shortlisted by C-DAC for Phase 1 ToT and Licensing of TETRA based products, will be **automatically shortlisted** for this phase also, and hence need not respond to this Eol.
2. Details of products and technologies offered for ToT/Licensing and the general approach to the process are detailed in Annexure-I (Information for Respondents) to this invitation.
3. Details of information to be furnished by respondents, along with Expression of Interest (Eol) are given in Annexure-II. Interested parties can submit the Eol, along with information solicited in Annexure-II in the given pro forma and relevant supporting documents.
4. A meeting of interested respondents shall be convened at C-DAC, Thiruvananthapuram to give an overview of the products which are ready for ToT, clarify the requirements and also to address the queries from the potential respondents. Interest for participation may be intimated in advance by e-mail to [krishku@cdac.in](mailto:krishku@cdac.in). [The date and /or time of this meeting shall be duly updated in C-DAC website.]
5. The respondent shall submit Eol and supporting documents in sealed envelope marked **"Eol for Transfer of Technology (ToT) and Licensing of TETRA based products/technologies"**. The Eol and supporting documents should reach *Head, Broadcast and Communications Group, C-DAC, Vellayambalam, Thiruvananthapuram-695033* **before 10:00 am on 31 March 2020**. The envelope should also have on it the full address of the contact person with cell phone number, on the side of the respondent.

6. At any time before the submission of EoI, C-DAC may carry out amendment(s) to this EoI document and/or the schedule, including the EoI submission deadline. The amendment will be made available on the same URL ([www.cdac.in](http://www.cdac.in)).
7. Prospective respondents, prior to submitting the EoI, may visit C-DAC with prior appointment, for further inputs on the products announced for ToT.
8. To assist the examination and evaluation of EoI, the respondents may be contacted for clarifications. The request for clarification and the response shall be in writing.
9. Respondents may also be called for making a presentation before the ToT Committee.
10. C-DAC representatives may visit facilities of the respondents for assessment of their capabilities with regard to the products/technologies covered under the EoI.
11. C-DAC will shortlist the respondents based on examination and evaluation of EoI by an empowered ToT Committee. C-DAC authorities reserve the right to accept or reject any of the applications without assigning any reason thereof.
12. C-DAC will issue tender documents to short-listed respondents for submission of final bids based on the terms and conditions as given in the tender documents.
13. Canvassing in any form would disqualify the applicant.
